# 2018 Call for Nominations

## AIBC Honorary Membership

---

The AIBC Council welcomes nominations for AIBC Honorary Membership. This honorary designation recognizes non-architects who have made especially noteworthy contributions to the profession of architecture in British Columbia. To uphold its prestige, this award is sparingly bestowed.

### **Criteria**

Consideration is given to those individuals whose contributions are seen to have significantly advanced the development and standing of the profession. Areas of consideration may include innovation, creativity, education, research, publication, and public service. Contributions by way of design excellence or service to the profession must be exceptional and sustained.

### **Qualifications**

The suitability of candidates should be reflected in the answers to the following questions as they apply:

- What is the nature of the outstanding contribution this person has made to the understanding, advancement or the practice of architecture?
- What has this person done to increase awareness and appreciation of the profession of architecture?
- What has this person done to demonstrate outstanding commitment to the profession of architecture?
- What are any relevant and notable accomplishments of the nominee?
- Why do you think this person is an outstanding candidate for honorary membership?

### **Eligibility & Nomination Process**

Award eligibility is open to non-architects who have made especially noteworthy contributions to the profession of architecture in British Columbia. Eligible candidates must be nominated by a minimum of five (5) Architects AIBC or Associates in good standing. Nomination submissions should outline the nominee's suitability in as much detail as possible, including a biographical profile and nomination statement detailing the qualifications and accomplishments of the candidate (minimum 500 words). Nominees must sign this nomination form and acknowledge AIBC Honorary Membership responsibilities.

### **Nomination Review Process & Member Vote**

All submissions received will be reviewed by the AIBC Registrar to ensure they meet the specified criteria. Recommendations will be forwarded to AIBC Council for its consideration and nomination at the 2017 AIBC Annual Meeting at which a member vote will determine whether or not honorary membership shall be granted.

## **Nomination Deadline**

The nomination package, supported by the signatures of the five nominators and the nominee, must be received by the AIBC office time stamped before 4:30 p.m. on February 16, 2018. It is recommended that the package be submitted in hard copy to Gord Richards Architect AIBC, Registrar at the Architectural Institute of British Columbia, 100 – 440 Cambie Street, Vancouver, BC V6B 2N5. Scanned forms sent by email to **registration@aibc.ca** are also accepted. Although all five nominator signatures and the nominee's signature must be on one form when submitted to the AIBC, signatures may be gathered by circulating the form electronically.
