

## 2020 Call for Nominations:

# The Barbara Dalrymple Memorial Award for Community Service

The AIBC Professional Recognition Committee welcomes nominations for *The Barbara Dalrymple Memorial Award for Community Service*. This award was established in honour of former MAIBC Barbara Dalrymple, a prominent Vancouver architect with a strong commitment to her profession and the community. It recognizes lifetime or exceptional contributions made by an **Architect AIBC**, **other individual registrant or architectural firm**, in the spirit of Barbara's dedication to positive change and her legacy of professional and public service. This award may annually be bestowed upon multiple individuals and/or firms.

#### Criteria

The award is <u>not</u> restricted to *pro bono* architectural service, and two types of community service may be considered:

- Time-limited Contribution: for a significant, time-limited architecture/community-related
  contribution to an identified geographical community or community of interest, or towards resolution
  of a challenging community issue or concern; can be awarded more than once; and
- Lifetime Contribution: for sustained architecture/community-related service with one group, or for
  multiple contributions to identified communities and community groups over time; can be awarded
  once.

Nominations for either type of community contribution may include the following examples of community service, in addition to others, as deemed appropriate by the nominator:

- · Research or education to benefit an identified community
- · Contributions to an identified community's built environment
- · Identity-building initiatives or cross-cultural relations
- · Community revitalization or heritage preservation
- · Urban planning or community development
- · Elected or appointed public service
- Advocacy on behalf of community issues
- · Contributions to community and professional associations

### **Eligibility and Nomination Process**

Award eligibility is open to any **Architect AIBC**, **other individual registrant** or **architectural firm**. Eligible candidates must be nominated by another AIBC registrant and/or a community member or group with firsthand knowledge of the contributions made. As above, nominees for time-limited contributions may be nominated and awarded more than once but successful nominations to recognize lifetime contributions is only awarded once. Submissions <u>must</u> outline the nominee's contribution in as much detail as possible, and

include a completed nomination form, letter of support from the nominator(s) (maximum 1,000 words), project descriptions that support the nomination, and additional letters of support from third parties (e.g. community groups, clients, etc.). The nomination package <u>must</u> include evidence from community members that the nominee's contributions made a positive impact.

#### **Nomination Review Process**

All nominations will be reviewed for completeness and accuracy and forwarded to the AIBC Professional Recognition Committee for its review and, if applicable, recommendation to AIBC Council.

### **Nomination Deadline**

The nomination package (completed nomination form and submission), must be received by the AIBC office before 4:30 p.m. on Friday, June 26, 2020. The nomination package must be submitted electronically to Shawna Chilton, Manager of Human Resources and Administration (schilton@aibc.ca) by the nominator (any additional nominators must be copied on the email).
